

## WestEd End User License Agreement for Math Pathways & Pitfalls Digital Resource Library

We have chosen to make these materials easily available as digital files for the benefit of educators. In exchange, we ask you to honor the hard work that goes into developing them.

Please read this End User License Agreement (this “Agreement”) carefully. By downloading, printing, copying, and/or using any of the files or content from the Math Pathways & Pitfalls Digital Resource Library (“Materials”), You or the entity You represent (collectively, “You”) acknowledge and agree that: (1) You have read this Agreement; (2) You understand it; and (3) You are bound by the terms of this Agreement, as this Agreement is enforceable like any written contract signed by You. If You do not agree to the foregoing, WestEd does not authorize You to print, copy, and/or use the Materials.

- 1. Limited License.** Subject to the terms and conditions of this Agreement, WestEd (“WestEd”) hereby grants to You a non-exclusive, non-transferable, and royalty-free limited license to print, and use the Materials for the sole purpose of professional development and/or course implementation at Your school, district, community college, or university. The Materials are available only to users who have purchased the Material. - 2. - 3. Your rights under this Agreement will terminate immediately without notice from WestEd if You fail to comply with any provision of this Agreement. Upon termination, You shall immediately cease use of the Materials, and destroy all copies of the Materials in Your possession or control. WestEd, in its sole discretion, may terminate or restrict your use or access to the Materials (or any part thereof) for any reason, including, without limitation, if WestEd believes You have violated or acted inconsistently with the letter or spirit of this Agreement. The provisions of this Agreement that by their nature contemplate performance after termination shall survive any such termination.
- 5. Disclaimer.** To the fullest extent permitted by applicable law, WestEd disclaims any and all warranties, express or implied, including, without limitation, the implied warranties of merchantability, fitness for a particular purpose, and non-infringement. The Materials are provided “as is.” WestEd does not warrant that the Materials will meet Your requirements, operate without interruption, or be error free.
- 6. Limitations of Liability.** In no event will WestEd be liable for special, indirect, incidental, punitive, or consequential damages, regardless of the form of action, even if the claim was reasonably foreseeable or if WestEd was advised of the possibility of such damages. In no event will WestEd’s aggregate liability under any and all claims arising out of this agreement exceed the total amount paid by You for the Materials. Some jurisdictions do not allow the exclusion or limitation of incidental or consequential damages, so these limitations may not apply to You.
- 7. Indemnity.** You agree to indemnify, defend and hold WestEd and its directors, officers, employees, agents and contractors harmless from and against any and all claims, damages, losses, costs (including without limitation reasonable attorneys’ fees) or other expenses that arise directly or indirectly out of or from (i) Your breach of any provision of this Agreement; or (ii) Your activities in connection with and use of the Materials.
- 8. Miscellaneous.** If any provision of this Agreement is held to be unenforceable, such provision shall be reformed to the extent necessary to make it enforceable so as to affect the intent of the parties, and the remainder of this Agreement shall continue in full force and effect. A waiver of any default is not a waiver of any subsequent default. This Agreement is binding upon and is for the benefit of the respective successors and assigns of the parties hereto. The parties acknowledge and agree that a material breach of this Agreement, and any action adversely affecting WestEd’s proprietary rights, would cause irreparable harm to WestEd for which a remedy at law would be inadequate and that WestEd shall be entitled to injunctive relief in addition to any remedies it may have hereunder or at law. This Agreement is the complete agreement between You and WestEd concerning the subject matter hereof, and supersedes any and all prior agreements and representations between WestEd and You related to the same subject matter.
